

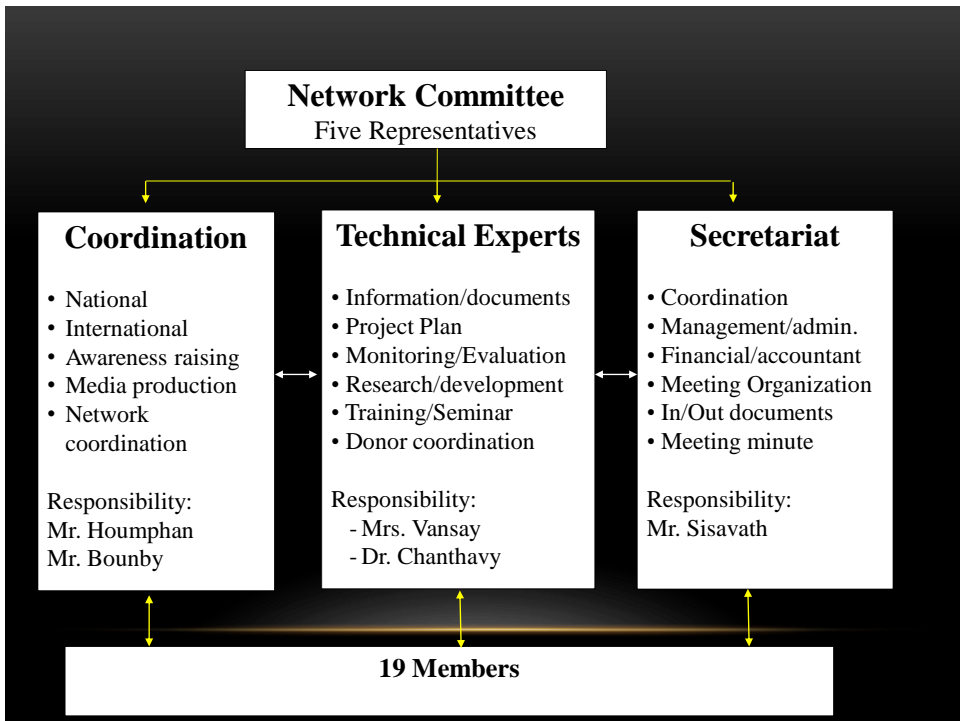

- With reference to the Memorandum for establishing the Lao CSO FLEGT members and for selecting their representatives to take part in the FLEGT-VPA movement

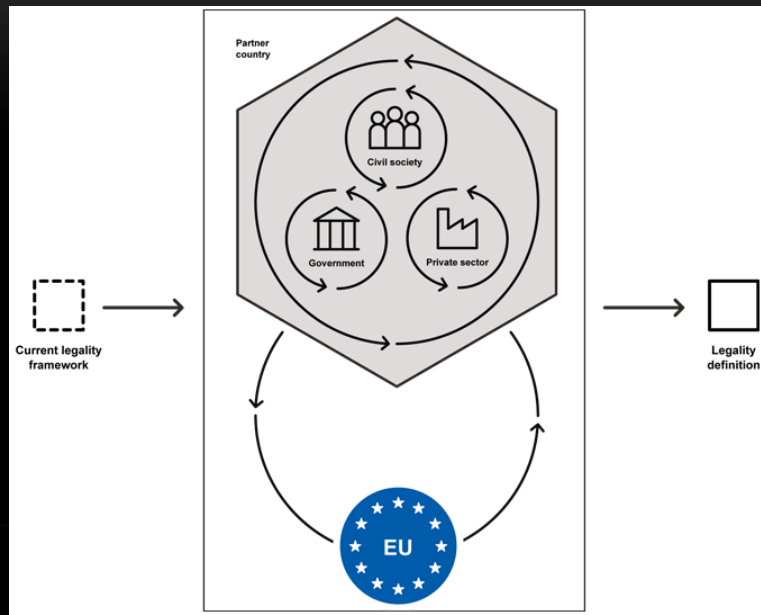
